- III. Approval/Modification of Minutes from July 17th, 2024 Executive Committee meeting: Director Caldwell made a motion to approve, Director Daniels seconded, motion was passed 7-0

investment from attending the conference, and wanted to ensure that the County as a whole would be represented. Director Daniels made a motion to grant \$5000, was seconded by Director Stone. Motion failed 2 yea 5 no. A second motion was made by Director Caldwell to grant \$7600, and was seconded by Director Hufford. Motion passed 5-2. Director Caldwell announced that the SHLA will pay an additional \$1200.
